### With ACE Highway eManifest

The Automated Commercial Environment (ACE) serves as U.S. CBP's electronic manifest program, streamlining the process for managing cargo data.

For highway carriers transporting goods into the U.S., compliance with this system is mandatory. This entails electronically reporting cargo and conveyance data by filing an ACE eManifest. The documents must be received and validated by the U.S. CBP at least one hour prior to arrival at the border.



### With ACI Highway eManifest

The Advanced Commercial Information (ACI) serves as the CBSA's electronic manifest program, streamlining the process for managing cargo data.

For highway carriers transporting goods into Canada, compliance with this system is mandatory. This entails electronically reporting cargo and conveyance data by filing an ACI eManifest. The documents must be received and validated by the CBSA at least 1 hour prior to arrival at the border.

## Before entering the U.S. or Canada's border

- Step 1** File and submit ACE / ACI Highway eManifest via CrimsonLogic's platform at least 1 hour prior to arrival at the border.
- Step 2** Any in-bond shipments must also be manifested in the truck's eManifest submission.
- Step 3** CrimsonLogic or your customs broker will file customs declaration.

## At the U.S. or Canada's border

- Step 4** Arrive at the border at least 1 hour after the eManifest is approved.
- Step 5** Present ACE or ACI coversheet for eManifest information to be retrieved.
- Step 6** After verification, the CBP or CBSA Officer will either release the truck or refer it for secondary processing.
